1. Anti-Trust Statement

Read out by Annette for the benefit of all members present.

2. Secretariat Report

Nicola presented the secretariat report (presentation attached).

Membership Status

ITSA currently has 23 members. At the end of 2019 Rolland Enterprises will be standing down as members but Wellking Technologies has recently been approved as a new member by the board and their membership should be formalised shortly. The aim is to reach 30 members and the work to achieve this is ongoing.

Latest Achievements

ITSA contributed to the ISO 22382 Guidelines for the content, security, issuance and examination of excise tax stamps which was published in November 2018.

The Association is increasing in recognition. It is frequently contacted by revenue authorities as an expert source of information, and some authorities have asked to become ITSA members. The ITSA secretariat is often the first point of contact and disseminates information and enquiries to its members, who then have the opportunity of engaging directly with the enquiring authority, if desired.

Current Projects

Current projects include:

Advocacy at FCTC Protocol Level – continuing to seek ways to make available our members' expertise to FCTC Protocol states involved in MOP2 2020.

Pursuing the legal challenge of EU TPD – ITSA has launched an appeal at the EU Court of Justice following the inadmissibility ruling on our case.

Modifying the Articles of Association to reflect governance experiences accumulated over the past four years.

Creating observer/associate membership status.

Looking at how we can reorganise ITSA for the future, including the work of the secretariat?

3. To Appoint Auditors for Next Fiscal Year

ITSA is not required to appoint auditors at this stage due to its current size.

4. Budget and Membership Fees

Nicola gave an update:

As at the end of August 2019, ITSA had 23 members each paying £5,000 per year / or pro rata. A discussion took place around including revenue authorities as observer members at a nominal fee.

The budget is currently in a healthy position, with a reserve of approximately £45,000. Attached is the status as at end August 2019, showing actuals, current forecast until the end of the year, original budget, and 2018 actuals as a comparison.



5. Comments from the Floor

- Marietta Ulrich-Horn, Securikett commented that It is positive that governments are now asking ITSA for information, as this raises the reputation of ITSA.
- Corinne Murcia, SURYS highlighted that an association should represent all members and that it was important that all members contributed and be active in the work of ITSA.
- Mark Deakes, Reconnaissance commented that the advocacy, standards and information that ITSA
 is providing is a good platform and ITSA is doing a good job.
- Nicola Sudan, ITSA Secretariat emphasised the need to get more members involved and the
 possibility of looking at a different structure in terms of actions and resources needed to achieve
 more engagement from members.
- Christine Macqueen, SICPA commented on the work of the five working groups and the need to generate sustained interest from a full range of members.
